APPROVE AMENDMENT TO THE DES MOINES COMMUNITY DEVELOPMENT BLOCK GRANT--DISASTER RECOVERY (CDBG-DR) CONTRACT (NUMBER 08-DRH-209) TO ACCEPT A SUPPLEMENTAL AWARD FOR MULTI-FAMILY HOUSING NEW PRODUCTION EAST VILLAGE GROWTH PARTNERS, LLC IN AN AMOUNT NOT TO EXCEED \$3,000,000 PLUS GENERAL ADMINISTRATION NOT TO EXCEED \$61,224.

WHEREAS, the Iowa Economic Development Authority, (IEDA) administers Community Development Block Grant Disaster Recovery (CDBG-DR) funds to assist with flood recovery pursuant to a statewide allocation plan approved by the U.S. Department of Housing Urban Development (HUD); and

WHEREAS, on April 20, 2009 by Roll Call 09-645, IEDA and the City of Des Moines entered into Contract 08-DRH-2009 pursuant to funds granted by IEDA to implement activities outlined in the Contract to assist in rebuilding after the floods of 2008; and

WHEREAS, the City and IEDA have amended IEDA contract 08-DRH-209 Fourteen times to incorporate more activities and more funding or to reduce funding; and

WHEREAS, in November, 2012, the City received notice from IEDA that additional funds were available for the production of new multi-family housing units for those CDBG Entitlement Cities and other cities impacted by the 2008 floods; and

WHEREAS, this application was known as CDBG-DR Multi-Family Funding Round #5 and the City could submit two multi-family projects;

WHEREAS on February 20, 2013 by Roll Call 13-0267, the Des Moines City Council reviewed nine potential projects and authorized submitting two projects for funding under the CDBG-DR Multi-Family Round #5; and

WHEREAS, on June 24, 2013, the City was notified that IEDA had awarded the City \$3,000,000 for the East Village Growth Partners, LLC mixed-use project to be located at 350 East Locust.

WHEREAS, IEDA has amended 08-DRH-209 to add the supplemental funds and has requested Amendment #15 be approved by the City and received in their office by July 31, 2013.
