HEARING FOR CONVEYANCE OF A GAS AND REGULATOR STATION EASEMENT LOCATED IN THE NORTHWEST CORNER OF THE INTERSECTION OF SE 20TH STREET AND EAST PARK AVENUE TO MIDAMERICAN ENERGY COMPANY FOR \$100

WHEREAS, MidAmerican Energy Company ("MidAmerican") has requested an easement on Cityowned property located at the northwest corner of the intersection of SE 20th Street and East Park Avenue as a part of a private MidAmerican project to relocate and replace existing underground gas and regulator vaults within street right-of-way to above-ground locations outside of street right-of-way; and

WHEREAS, MidAmerican has offered to the City of Des Moines the purchase price of \$100.00 for the purchase of a permanent easement for gas and regulator station easement within said City-owned property to accommodate the MidAmerican relocation project, which purchase price reflects the fair market value of the easement as determined by the City's Real Estate Division; and

WHEREAS, the City and the public will not be inconvenienced by the sale and conveyance of the permanent easement as requested by MidAmerican; and

WHEREAS, on July 29, 2013, by Roll Call No. 13-1197, it was duly resolved by the City Council that the proposed conveyance of the easement be set down for hearing on August 12, 2013, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of the proposal to convey the permanent easement was given as provided by law, setting forth the time and place for hearing on the proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed conveyance of the permanent easement described below are hereby overruled and the hearing is closed.
- 2. The public would not be inconvenienced by reason of the conveyance of a permanent gas and regulator station easement to MidAmerican Energy Company across City-owned property located at the northwest corner of SE 20th Street and East Park Avenue, more specifically described below, for \$100, and the conveyance of said easement is hereby approved, subject to final negotiation of easement terms and approval as to form by the City's Legal Department:

THE NORTH 10 FEET OF THE SOUTH 30 FEET OF THE WEST 10 FEET OF THE EAST 25 FEET OF OUTLOT W, PARK FOREST No.1, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

- 4. The Deputy City Clerk is authorized and directed to forward the original of the easement, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Real Estate Division of the Engineering Department for the purpose of causing the documents to be recorded.
- 5. The Real Estate Division Manager is authorized and directed to forward the original of the easement, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
- 6. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the easement and copies of the other documents to the grantee.
- 7. The proceeds from the sale of this property shall be deposited into the following account: Fund: SP767, Org: ENG980500.
