contains a vacant lot assessed as residential property that is suitable for construction of a single-family dwelling; and

WHEREAS, Greater Des Moines Habitat for Humanity has taken a tax deed to the real estate and will be building a new single-family dwelling for sale to a homeowner; and

WHEREAS, Greater Des Moines Habitat for Humanity is a non-profit corporation located at 2200 E. Euclid Avenue, Des Moines, IA 50314, Lance Henning, Executive Director; and

WHEREAS, the parcel is encumbered with liens for substantial amounts of special assessments owed the City as itemized below; and

WHEREAS, waiving such assessments is in the best interest of the City of Des Moines and Greater Des Moines Habitat for Humanity; and

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa as follows:

- 1. That the special assessments, accrued interest, and fees owed to the City on the parcel at 1546 22nd Street, specifically itemized below, are hereby dismissed and released.
