2013-2014 SIDEWALK PROGRAM;
RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE
BIDDER AS MPS ENGINEERS, P.C., UMESH G. SHETYE, PRESIDENT, \$82,833.00

WHEREAS, on August 26, 2013, under Roll Call No. 13-1308, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2013-2014 Sidewalk Program, 09-2013-005

The improvement includes construction of Portland cement concrete sidewalk 4 feet wide and 4 inches thick (6 inches through driveways/driveway approaches) and 6 inch ADA compliant curbramps, includes grading, sodding, traffic control and other incidental items; in accordance with the contract documents, including Plan File Nos. 553-204/225, along the south side of E. Gray Street from Indianola Avenue east approximately 525' to meet existing sidewalk at 341. E. Gray Street, and also along the north side of E. Sheridan Avenue from 2658 E. Sheridan Avenue east approximately 225' to Hubbell Avenue, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.
