SET HEARING FOR VACATION OF CITY RIGHT-OF-WAY AND CONVEYANCE OF A SUBSURFACE EASEMENT WITHIN SW 2ND STREET AND MARKET STREET ADJOINING 101 SW 2ND STREET TO DSM COMMON, INC. FOR \$3,342.00

WHEREAS, DSM Common, Inc. is the owner of the real property locally known as 101 SW 2nd Street, and has offered to the City of Des Moines the purchase price of \$3,342.00 for the vacation and purchase of an easement for subsurface building encroachment within the subsurface portion of City right-of-way within SW 2nd Street and Market Street adjoining 101 SW 2nd Street, as legally described below, for the purpose of using, repairing, and maintaining the footings and foundations extending from the adjoining parking garage at 101 SW 2nd Street, which price reflects the fair market value of the easement as currently estimated by the City's Real Estate Division; and

WHEREAS, such subsurface portion of City-owned SW 2nd Street and Market Street has been determined by the City Engineer and City Traffic Engineer to have no significant impact upon the public use of SW 2nd Street or Market Street, and the City will not be inconvenienced by the vacation thereof and sale of a subsurface easement therein.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a subsurface portion of City right-of-way within SW 2^{nd} Street and Market Street adjoining the property locally known as $101 \text{ SW } 2^{nd}$ Street, more specifically described as follows:
