**AUTHORIZING SUBMITTAL OF
STP AND TAP FUND FY2018 APPLICATIONS TO THE
DES MOINES METROPOLITAN PLANNING ORGANIZATION**

WHEREAS, The City of Des Moines is a full member of the Des Moines Area Metropolitan Planning Organization (MPO); and

WHEREAS, the Federal Surface Transportation Program (STP) and Transportation Alternatives Program (TAP) provide funding to local jurisdictions for the construction of eligible projects; and also

WHEREAS, the programs are administered by the Des Moines Area MPO that prioritizes and ranks all project applications;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

That the City Manager is hereby authorized to submit applications to the Metropolitan Planning Organization for Federal Surface Transportation Program (STP) and Transportation Alternatives Program (TAP) funds for the following projects:

1. Regionally Significant Project--Major Construction (New) Category: Southeast Connector--SE 30th Street to US 65 Beltway
2. Regionally Significant Project--Major Construction (Existing) Category: East Douglas Avenue Widening--E 42nd Street to E 56th Street
3. Regionally Significant Project--Major Construction (Existing) Category: Indianola Avenue Widening--East Army Post Road to US 69
4. Other Projects--Preservation Category: 2nd Avenue Bridge over the Des Moines River
5. Other Projects--Preservation Category: Locust Street Bridge over the Des Moines River

BE IT FURTHER RESOLVED:







