SET HEARING FOR CONVEYANCE OF VACATED SEGMENTS OF THE NORTH-SOUTH ALLEY NORTH OF CLEVELAND AVENUE AND SOUTH OF WASHINGTON AVENUE BETWEEN E. 18TH STREET AND DE WOLF STREET TO CRANE CHAPEL CHURCH OF GOD IN CHRIST FOR \$200 AND TO JOSHUA SMITH FOR \$75

WHEREAS, on August 3, 1981, by Roll Call No. 3987, City Council approved and adopted Ordinance No. 9,985 vacating all of the north/south alley right-of-way north of Cleveland Avenue and south of Washington Avenue between East 18th Street and De Wolf Street, including two segments thereof adjoining the real properties locally known as 1440 De Wolf Street and 1451 East 18th Street respectively (collectively "Property"), as legally described below, subject to the City Plan and Zoning Commission recommendation that said vacation be subject to reservation of easements for all utilities in place within the vacated right-of-way; and

WHEREAS, Crane Chapel Church of God in Christ owns the real property locally known as 1440 De Wolf Street, adjoining one segment of the Property, and has offered to the City of Des Moines the purchase price of \$200.00 for the purchase of such vacated segment of City-owned property, which price reflects the fair market value of said segment of the Property as currently estimated by the City's Real Estate Division; and

WHEREAS, Joshua Smith owns the real property locally known as 1451 East 18th Street, adjoining the second segment of the Property, and has offered to the City of Des Moines the purchase price of \$75.00 for the purchase of such vacated segment of City-owned property, which price reflects the fair market value of said segment of the Property as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the Property proposed to be sold and the City will not be inconvenienced by the sale of said Property.
