RESOLUTION CLOSING PUBLIC HEARING ON ORDINANCE AMENDING THE ELECTRIC ENERGY AND GAS FRANCHISES GRANTED TO MIDAMERICAN ENERGY COMPANY RELATING TO TEXTUAL CLARIFICATIONS OF THE FRANCHISE FEE

WHEREAS, on November 18, 2013 by Roll Call No. 13-1800, it was duly resolved by the City Council that in accordance with Section 364.2(4)(a) of the Iowa Code, an amendment to said electric energy and gas franchises granted to MidAmerican Energy Company relating to textual clarifications to the franchise fee which do not increase the rate of the franchise fee be set for public hearing on December 9, 2013, at 5:00 p.m., in the Council Chambers at City Hall; and

WHEREAS, due notice of the hearing was published in the Des Moines Register on December 3, 2013, as provided by law, setting forth the time and place for hearing on the proposed amendment to the electric energy and gas franchises granted to MidAmerican Energy Company; and

WHEREAS, in accordance with the notice those interested in the proposed amendment to the electric energy and gas franchises granted to MidAmerican Energy Company, both for and against, have been given the opportunity to be heard with respect thereto and have presented their views to the City Council; and

WHEREAS, the Legal Department has prepared an ordinance amending the electric energy and gas franchises granted to MidAmerican Energy Company relating to textual clarifications to the franchise fee which ordinance has been available for public review and inspection in the Office of the City Clerk.

- 2. It is hereby determined that it would be in the best interests of the City of Des Moines and its residents to amend the electric energy and gas franchises granted to MidAmerican Energy Company to make textual clarifications to the franchise fee.
- 3. In accordance with Section 364.2(4)(b) of the Iowa Code, the City Council shall dispense with an election to approve of the proposed ordinance amending the electric energy and gas franchises granted to MidAmerican Energy Company unless a valid petition requesting submission of the proposed ordinance to the voters is accepted for timely filing with the City of Des Moines.
- 4. Upon final passage by the City Council and publication of the proposed ordinance amending the electric energy and gas franchises granted to MidAmerican Energy Company, the Mayor shall promptly notify the State of Iowa Director of Revenue of such action.
