WHEREAS, on November 18, 2013 by Roll Call No. 13-1799, it was duly resolved by the City Council that, in accordance with Section 364.2(4)(a) of the Iowa Code, an amendment to said electric energy and gas franchises relating to a temporary increase to the franchise fee to be used solely toward payment of the *Kragnes v. City of Des Moines* judgment be set for public hearing on December 9, 2013, at 5:00 p.m., in the Council Chambers at City Hall; and

WHEREAS, due notice of the hearing was published in the Des Moines Register on December 3, 2013, as provided by law, setting forth the time and place for hearing on the proposed amendment to the electric energy and gas franchises granted to MidAmerican Energy Company; and

WHEREAS, in accordance with the notice those interested in the proposed amendment to the electric energy and gas franchises granted to MidAmerican Energy Company, both for and against, have been given the opportunity to be heard with respect thereto and have presented their views to the City Council; and

WHEREAS, the Legal Department has prepared an ordinance amending the electric energy and gas franchises granted to MidAmerican Energy Company relating to a temporary increase in the franchise fee to be used solely toward payment of the *Kragnes v. City of Des Moines* judgment which ordinance has been available for public review and inspection in the Office of the City Clerk.
