CONTRACT FOR SANITARY SEWER IMPROVEMENTS, 2106 ECHO VALLEY DRIVE,
BETWEEN KENYON CONSTRUCTION, INC. AND CASEY'S MARKETING COMPANY

WHEREAS, on November 10, 2008 under Roll Call No. 08-1944, the City Council approved a private construction contract in the amount of \$84,894.24, between Kenyon Construction, Inc., Greg Kenyon, President, 1959 Grant Avenue, Guthrie Center, IA, 50115 - as Contractor, and Casey's Marketing Company, Eli J. Wirtz, Secretary-Treasurer, P.O. Box 3001, Ankeny, IA, 50021 - as Owner, for construction of Sanitary Sewer Improvements described as construction of sanitary sewer to serve the new Casey's Store at 2106 Echo Valley Drive in accordance with Plan File No. 469-128., and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
