WHEREAS, Hall & Associates has submitted a billing dated November 15, 2013 in the amount of \$12,477.24 with the City's portion being \$1,039.77 and a billing dated December 17, 2013 in the amount of \$2,352.00 with the City's portion being \$196.00 for a total amount of due \$1,235.77; and

WHEREAS, the City Legal Department has reviewed said billings and verified them to be correct and recommends payment.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the billings be forwarded to the Finance Department, and that the Finance Director be and is hereby authorized and directed to issue a check in the amount of \$1,235.77 to Hall & Associates.
