# HOLD HEARING FOR CONVEYANCE OF A PERMANENT EASEMENT FOR RECREATIONAL TRAIL AND A PERMANENT ACCESS EASEMENT TO POLK COUNTY, IOWA, ACTING THROUGH THE POLK COUNTY CONSERVATION BOARD FOR \$1

WHEREAS, the City of Des Moines is the owner of real property located north of Army Post Road and east of Iowa Highway 28 ("City-owned Property") that contains the Great Western Trail owned by the Polk County and controlled by the Polk County Conservation Board; and

WHEREAS, the City of Des Moines plans to reconstruct the Army Post Bridge where the Great Western Trail crosses under Army Post Road; and

WHEREAS, the City needs to grant a Permanent Easement for Recreational Trail and a Permanent Access Easement to Polk County, Iowa, acting through the Polk County Conservation Board over the City-owned Property in accordance with Iowa Code Section 364.7(3) for the public purpose of access to and use of the Great Western Trail; and

WHEREAS, there is no known current or future public need for the easement area to be conveyed and the City will not be inconvenienced by the conveyance of these easements; and

WHEREAS, on January 13, 2014, by Roll Call No. 14-0048, it was duly resolved by the City Council that the proposed conveyance of the easements be set down for hearing on January 27, 2014, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to convey the easements was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in this proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the conveyance of the easements, as described below, are hereby overruled and the hearing is closed.
- 2. There is no current or known public need or benefit for the property described below, and the public would not be inconvenienced by reason of the conveyance of a Permanent Easement for Recreational Trail and a Permanent Access Easement, as legally described below, to Polk County, Iowa, acting through the Polk County Conservation Board, over City-owned property located north of Army Post Road and east of
