## APPROVAL OF THE SOUTHWEST 14TH QUIET STREET CONCEPTUAL PLAN

WHEREAS, the Park and Recreation Department is charged with providing recreational opportunities, leisure activities, and facilities throughout Des Moines; and

WHEREAS, improving the on-street bicycle network by creating this quiet street supports the City's goals to be a Bicycle Friendly Community; and

WHEREAS, on June 13, 2011, by Roll Call No. 11-1046 the Des Moines City Council adopted the Bicycle and Trail Master Plan as a part of the City's 2020 Community Character Plan and the plan identified SW 14<sup>th</sup> Street as a quiet street connection as one of three priority projects that could have a major impact on bicycling in the City;

WHEREAS, a "quiet street" is a lower-volume, lower-speed street on which motorists and bicyclists share the same space through the aid of signage, pavement markings, traffic-calming elements, intersection treatments, and traffic diversion elements that help to establish it as a preferential route for bicyclists; and

WHEREAS, the City desires that the Southwest 14<sup>th</sup> Quiet Street project be completed, which will connect the Southtown Trail near Gray's Lake Park on the north to the Blank Park Zoo on the south along Casady Drive and Southwest 14<sup>th</sup> Street; and

WHEREAS, the conceptual plan was developed in cooperation with staff representing Parks and Recreation, Traffic and Transportation, Community Development, Engineering, Public Works, Police, and Fire Departments, DART, the Blank Park Zoo, and Des Moines Public Schools; and

WHEREAS, on September 10, 2013 the concept was presented to the Traffic Safety Committee for informational purposes, with no action to be taken; and

WHEREAS, on December 9, 2013, the Des Moines and Polk County Trails and Greenways Advisory Committee reviewed the conceptual plan and unanimously recommended approval; and

WHEREAS, on December 16, 2013, the Park and Recreation Board reviewed the Southwest 14<sup>th</sup> Quiet Street conceptual plan and a majority (12-2) voted to recommend to City Council that it approve the plan; and
