**AMENDING THE FAIRMONT PARK NEIGHBORHOOD BOUNDARY TO
INCLUDE THE AREA FORMERLY KNOWN AS THE GARTON WEST
NEIGHBORHOOD.**

WHEREAS, on May 24, 1993, by Roll Call No. 93-2026, the City Council approved the Neighborhood Recognition Policy (the "Policy") which establishes procedures for the formal recognition of neighborhood associations by the City of Des Moines, and authorizes Recognized neighborhoods to advise the City on issues of concern; and

WHEREAS, on November 6, 2000, by Roll Call No. 00-4213, the Fairmont Park Neighborhood Association was Recognized by the City of Des Moines; and

WHEREAS, on May 19, 2008, by Roll Call No. 08-865, the Garton West Neighborhood was removed from the list of Recognized Neighborhood Associations by the City of Des Moines; and

WHEREAS, on January 19, 2014, the Fairmont Park Neighborhood Association notified staff that they had voted in favor of expanding the boundaries of their neighborhood to include the area formerly known as the Garton West Neighborhood and shown on the accompanying map; and

WHEREAS, on February 5, 2014, the Neighborhood Revitalization Board voted to recommend to the City Council that the City of Des Moines amend the Fairmont Park Neighborhood boundaries to include the area formerly known as the Garton West Neighborhood; and

WHEREAS, the amended boundaries of the Fairmont Park Neighborhood Association will include the area bordered on the west by Delaware Avenue, on the north by E. Euclid Avenue, on the south by Easton Boulevard, and on the east by E. 33rd Street and Hubbell Avenue.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the boundaries of the Fairmont Park Neighborhood Association are hereby amended to include the area formerly known as the Garton West Neighborhood, with the amended boundaries to be as shown on the accompanying map.
