WHEREAS, to fulfill the above-referenced requirements, the City Council will conduct a public hearing during its regular meeting on March 24, 2014, at 5:00 p.m., to review the 2013 HUD Consolidated Plan Program Year performance and consider approval of the CAPER for said Program Year and a copy of the CAPER shall be made available for public review at the City Clerk's Office and at all library branches in order to provide citizens with the opportunity to participate in the hearing.
