WHEREAS, the term of the second mortgage has expired and the Borrower has applied for forgiveness of the second mortgage, and staff has determined that the Borrower has successfully met all of the program requirements and qualifies for mortgage forgiveness.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board, that on behalf of the City of Des Moines, Municipal Housing Agency, the City Manager or his designee, the Housing Director, is hereby authorized and empowered to execute a release and satisfaction of the Affordable Homeownership mortgages, liens, covenant, and other security instruments for the Property, in such form approved by Legal Counsel.

BE IT FURTHER RESOLVED that the City Manager or his designee is authorized to direct that those instruments be recorded with the Polk County Recorder's Office.
