Box 3374, Des Moines, IA, 50313 dated March 24, 2014, for the construction of the following improvement:

Park Avenue Railroad Crossing Improvements at S.W. 56th Street, 06-2014-006

The improvement includes construction of full depth asphalt railroad approach pavement, pavement removal, traffic control, grading, site restoration, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 557-005/015, on Park Avenue at the Siegwark railroad crossing located 690 feet east of S.W. 56th Street, Des Moines, Iowa

BE IT FURTHER RESOLVED: That the Mayor be and is hereby authorized and directed to execute said contract on behalf of the City of Des Moines, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments, and the City Clerk, be and is hereby authorized and directed to attest to same. No contract shall be deemed to exist between the City of Des Moines and said Bidder until said contract has been executed by the Bidder, and shall have been approved by this Council and executed by the Mayor and attested to by the City Clerk.

BE IT FURTHER RESOLVED: That after said contract has been executed by the Mayor, the City Clerk be and is hereby authorized and directed to return the Contractor's bid security.

BE IT FURTHER RESOLVED: That the attached Permission to Sublet form, from said Contractor requesting permission to sublet designated items, be and is hereby approved, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments; and each subcontractor is hereby granted permission to work on said improvement.
