RELEASE OF GENERAL FUND ALLOCATION TO THE MUNICIPAL HOUSING AGENCY AND APPROVAL OF PROPOSED COMMITMENTS FOR FUNDING ALLOCATIONS AND SET ASIDE FOR THE COMMUNITY ORIENTED POLICING SERVICES (COPS) GRANT PROGRAM

WHEREAS, by Roll Call No. 13-0615 of April 8, 2013, the City Council approved a funding allocation of up to \$250,000 to the Municipal Housing Agency Section 8 administrative account and alternative funding resources have since been identified and utilized for such purposes; and

WHEREAS, by Roll Call No. 13-1818 of November 18, 2013, the City Council approved the Office of Community Oriented Policing Services (COPS) program grant to provide partial funding for nine full-time officer positions for three years with the requirement that such positions be funded entirely by the City for a fourth year.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the \$250,000 allocation to the Municipal Housing Agency Section 8 administrative account by Roll Call No. 13-0615 is hereby terminated and released.

BE IT FURTHER RESOLVED that in order to fully fund the City's obligations for the fourth year of the COPS grant program, the City shall commit a funding allocation of \$200,000 during the fiscal year ending June 30, 2015, shall commit a funding allocation in aggregate of \$350,000 during the fiscal year ending June 30, 2016 and shall commit a funding allocation in aggregate of \$400,000 during the fiscal year ending June 30, 2017.

BE IT FURTHER RESOLVED that the termination and release of the funding allocation to the Municipal Housing Agency and the commitments for future funding allocations to the COPS grant program shall be incorporated in the annual audits and in the annual budgets for the applicable fiscal years and any amendments thereto for presentation to the City Council for approval at later dates.
