RESOLUTION OF SUPPORT ENDORSING THE DES MOINES AREA METROPOLITAN PLANNING ORGANIZATION (MPO) TOMORROW PLAN

WHEREAS, the City of Des Moines is a member of the Des Moines Area Metropolitan Planning Organization ("MPO"), an organization under Iowa Code Chapter 28E of county and city governments established to carry out collaborative planning activities for the metropolitan area; and

WHEREAS, the Federal Interagency Partnership for Sustainable Communities (U.S. Department of Housing and Urban Development (HUD), U.S. Environmental Protection Agency (EPA) and U.S. Department of Transportation (DOT)) has selected Greater Des Moines as one of 45 initial regions to pursue regional sustainable development planning, and has provided grant funding to the MPO to study regional sustainability initiatives; and

WHEREAS, the City and its representatives to the MPO have participated in the development of The Tomorrow Plan, a copy of which is on file in the office of the City Clerk, setting forth a voluntary, best-practices guide for local jurisdictions, stakeholder organizations and 28E organizations, including the City and the MPO, which does not dictate specific funding strategies or policy decisions that are within the authority of the City; and

WHEREAS, the Tomorrow Plan incorporates, among other terms, the following standards for best-practices on sustainability:

- 1. Strengthening diversity and equity in order to promote the environmental and economic health of the Greater Des Moines region, the City, its neighborhoods, and its individuals;
- 2. Staying attentive to the needs of future generations and to the current shifting trends in demographics, economics, and nature, as well as expectations of significant regional growth;
- 3. Integrating social, economic, and natural resource needs and opportunities with a strategic direction for the region's future;
- 4. Building on current cooperative ventures throughout the region to find additional opportunities to collaborate, create efficiencies, and provide higher quality services to residents;
- 5. Recognizing that a vibrant, lasting future includes a healthy environment, in addition to expanded choices and access within the areas of health, food, transportation, housing, work, culture, education, and play; and
- 6. Taking steps today that will lead to a well-balanced tomorrow that maximizes the betterment of the entire region; and
