RESOLUTION SCHEDULING PUBLIC HEARING ON THE VACATION AND LEASE OF PUBLIC RIGHT-OF-WAY FOR A SIDEWALK CAFE IN THE ALLEY WEST OF AND ADJOINING 210 COURT AVENUE (Tonic on Court)

The North/South alley right-of-way lying West of and adjoining Lot 11, Block 30, Original Town of Fort Des Moines, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

- 2. If the City Council first decides to vacate the above described right-of-way, the City of Des Moines proposes to lease such vacated right-of-way to Riley Drive Entertainment XIII, Inc., d/b/a Tonic on Court, for the operation of a for sidewalk cafe.
- 3. The City Council shall consider the adoption of said ordinance and the lease of such real estate at a public hearing to be held on May 19, 2014, at 5:00 p.m., in the Council Chambers.
- 4. That the City Clerk is hereby authorized and directed to publish notice of said proposal in the form hereto attached all in accordance with §362.3 of the Iowa Code.
