## SET HEARING FOR CONVEYANCE OF A PORTION OF THE VACATED EAST/WEST ALLEY RIGHT-OF-WAY ADJOINING 2815 FRANKLIN AVENUE TO BEVERLY J. MUGAN FOR \$270

WHEREAS, on August 23, 1999, by Roll Call No. 99-2691, City Council approved and adopted Ordinance No. 13,746 vacating the east/west alley right-of-way between Franklin Avenue and Allison Avenue, extending east from 30<sup>th</sup> Street, including the portions thereof adjoining 2815 Franklin Avenue, subject to the reservation of an easement for all utilities in place and reservation of right of entry for servicing same; and

WHEREAS, Beverly J. Mugan, owner of 2815 Franklin Avenue, has offered to the City of Des Moines the purchase price of \$270.00 for the purchase of the portion of the vacated alley right-of-way adjoining 2815 Franklin Avenue for incorporation into her adjoining property, which price reflects the fair market value of said portion of vacated alley right-of-way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the vacated alley right-of-way proposed to be sold and the City will not be inconvenienced by the sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:
