RESOLUTION OF SUPPORT ENDORSING THE CAPITAL CROSSROADS: CAPITAL CORE NEIGHBORHOOD IMPROVEMENT IMPLEMENTATION PLAN

WHEREAS, the City of Des Moines and its staff, and local public and private leaders and representatives, are participants in the Capital Crossroads strategic planning program for the Greater Des Moines region, and specifically in the Capital Core plan and Neighborhood Improvement Subcommittee thereof, as established to carry out collaborative planning activities for the metropolitan area; and

WHEREAS, the City and its representatives to the Capital Core plan and Neighborhood Improvement Subcommittee have participated in the development of the Capital Crossroads: Capital Core Neighborhood Improvement Implementation Plan, a copy of which is on file in the office of the City Clerk, setting forth a voluntary plan for local jurisdictions and stakeholder organizations, including the City, which does not dictate specific funding strategies or policy decisions that are within the authority of the City; and

WHEREAS, the Neighborhood Improvement Implementation Plan incorporates, among other terms, the following proposed initiatives:

- Addressing blighted residential properties by identifying and acquiring such
 properties, creating a land bank for rehabilitation and redevelopment purposes,
 enacting an exterior property maintenance code for private ownership which is
 enforced at time-of-sale, and creating a handbook of best practices and incentive
 programs;
- 2. Building value-added housing in existing neighborhoods by creating and packaging sites for infill development, researching development incentives and best practices, and promoting development adjoining workplaces;
- 3. Revitalizing neighborhood commercial areas by creating a strategic plan, increasing funding for Neighborhood Development Corporation, addressing vacant and blighted commercial properties and increasing funding for infrastructure and streetscape projects;
- 4. Upgrading infrastructure by bringing neighborhood infrastructure up to minimum standards, increasing investment in the Neighborhood Infrastructure Rehabilitation Program, coordinating infrastructure improvements with commercial development, and funding neighborhood infrastructure projects; and
- 5. Improving perceptions and connections of Des Moines neighborhoods and its school district by developing a coordinated marketing initiative, improving communication, and developing and supporting neighborhood leadership; and
