WHEREAS, asphalt rollers compliant with ITEM 1 are also available from Star Equipment per State of Iowa Department of Transportation (DOT) contract 4425-16 at a total cost of \$36,494.00 for two (2) units; and

WHEREAS, Municipal Code section 2-726 (c) provides for the purchase of goods and/or services from contracts established by the State of Iowa Department of General Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, the low dollar compliant bid for ITEM 2 was received from Titan Machinery, 2290 NE 54th Ave., Des Moines, IA 50313, Ben Pias, President, at a total cost of \$39,657.05; and

WHEREAS, funding is available from CM024021/Equipment Replacement, and

WHEREAS, the Procurement Administrator and the Fleet Maintenance Manager recommends approval of the State of Iowa DOT contract purchase for LINE 1 from Star Equipment at a total cost of \$36,494.00, and the low dollar compliant bid for ITEM 2 from Titan Machinery at a total cost of \$39,657.05;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the aforementioned recommendation for three (3) replacement asphalt rollers at a total cost of \$76,151.05.
