RESOLUTION APPROVING AGREEMENT BETWEEN THE DES MOINES METRO WASTE AGENCY D/B/A METRO WASTE AUTHORITY AND THE CITY OF DES MOINES, IOWA REGARDING DISPOSAL OF WASTE FROM 1422 SCOTT AVENUE

WHEREAS, property at 1422 Scott Avenue (hereinafter the "Property") within the City of Des Moines (City) is the site of a former mixed construction and demolition recycling facility; and

WHEREAS, the owner/operator stopped operating and closed the recycling facility without properly disposing of materials remaining on the Property; and

WHEREAS, the facility suffered extensive fire damage beginning on August 29, 2013; and

WHEREAS, the Iowa Department of Natural Resources (DNR) and the City both desire that the facility be demolished through the removal of concrete and metals for recycling and the removal of other materials for disposal; and

WHEREAS, the DNR and the City have negotiated an Agreement relating to the funding of the removal of debris, demolition of the structures and removal of structure rubble, recovery of scrap metal and concrete for recycling from the Property as a pilot project and are entering into an Agreement to serve as a demonstration project for the recovery of recyclables from fire damaged sites in the state, to facilitate recovery of scrap metal and concrete for recycling in an effort to minimize materials sent to the landfill to the extent determined feasible by the City; and

WHEREAS, the project will involve removal of all debris, loading and hauling of debris and rubble to a landfill, demolition of structure(s) on the Property, removal of paving, footings and the 80 ton truck scale, loading and hauling of concrete and scrap metal to recyclers; and

WHEREAS, the Metro Waste Authority (MWA) and the City have negotiated an Agreement for the MWA to assist the DNR and the City in this pilot project by agreeing to accept the debris/rubble that cannot be recycled at MWA's as special waste.
