APPROVAL OF CDBG PROJECT AGREEMENT WITH NEIGHBORHOOD DEVELOPMENT CORPORATION (NDC) FOR THE ACQUISITION, DEMOLITION AND REDEVELOPMENT OF ASBURY CHURCH LOCATED AT 1600 CAPITOL AVENUE

WHEREAS, Asbury Church (also known as Lighthouse Full Gospel Baptist Church), located at 1600 Capitol Avenue, was severely damaged by a fire and the structure poses a public nuisance to the Capitol East Neighborhood; and

WHEREAS, the acquisition and demolition of Asbury Church was identified as a high priority in the Capitol East Neighborhood Plan; and

WHEREAS, Neighborhood Development Corporation proposes to acquire and demolish the Asbury Church and, with City staff, to select a suitable for-profit or non-profit housing developer to purchase the property from NDC, subject to affordability covenants and with purchase proceeds returned to the City as project income, for development of a new single-family home on the property following demolition to be sold to an individual or family earning less than 80% of the Area Median Income as defined by the U.S. Department of Housing and Urban Development; and

WHEREAS, the City of Des Moines has allocated \$318,000 of Community Development Block Grant (CDBG) funding for fiscal year 2014 for Neighborhood Revitalization Plan Implementation; and

WHEREAS, the City proposes to utilize \$300,000 of such CDBG funding to assist NDC in the acquisition, demolition and redevelopment of Asbury Church pursuant to the Neighborhood Revitalization Plan; and

WHEREAS, NDC's proposed project for acquisition, demolition and redevelopment of the Asbury Church property is set forth in a CDBG Project Agreement between the City and NDC, as on file in the office of the City Clerk, and, due to the nature and amount of such Agreement, the Agreement is being presented to City Council for consideration and approval.
