RESOLUTION AUTHORIZING AND APPROVING RELEASE OF MORTGAGE GRANTED BY PRINCIPANT HOTEL COMPANY, L.C. FOR HOTEL FORT DES MOINES PROPERTY

WHEREAS, on March 20, 2000, by Roll Call No. 00-810, the Des Moines City Council approved an agreement between the City of Des Moines and Principiant Hotel Company, L.C. ("Principiant"), then-owner of the Hotel Fort Des Moines property, addressing enhancement of the Hotel Fort Des Moines and understandings with respect to hotel access, hotel parking and skywalk connections in relation to the Allied Gateway Campus Project; and

WHEREAS, on May 20, 2002, by Roll Call No. 02-1322, the City Council held a public hearing and approved a proposal to sell City-owned property locally known as 1013 Mulberry Street and 1016 Walnut Street to Principiant for \$161,676, with down payment made of \$55,900 and mortgage and promissory note granted by Principiant to the City for the balance of \$105,676 at a rate of four percent (4%) to be repaid over a ten-year period; and

WHEREAS, as required by Roll Call No. 02-1322, Principiant provided to the City a Mortgage, dated May 20, 2002 and filed on June 13, 2002 in Book 9182, Pages 244-249 in the office of the Polk County Recorder, in the original principal sum of \$105,676; and

WHEREAS, Principiant has complied in full with the terms of said Mortgage and has requested release thereof, and the City is obligated to provide release of said Mortgage.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The release of the Mortgage dated May 20, 2002 and filed on June 13, 2002 in Book 9182, Pages 244-249 in the office of the Polk County Recorder, which Mortgage was given by Principiant Hotel Company, L.C. to the City of Des Moines, be and is hereby approved.
2. The acting City Manager is authorized and directed to sign the Release of Mortgage, and the Office of Economic Development is authorized and directed to forward the original of the Release to the Polk County Recorder's Office for the purpose of causing said document to be recorded.
