APPROVING AND AUTHORIZING EXECUTION OF 28E AGREEMENT WITH MEMBERS OF THE POLK COUNTY EMERGENCY MANAGEMENT COMMISSION FOR FUNDING OF EMERGENCY MANAGEMENT ADMINISTRATION

WHEREAS, pursuant to Iowa Code §29C.9 there is established in each county an emergency management commission to provide direction for delivery of the emergency management services of planning, administration, coordination, training and support for local governments and their departments; and

WHEREAS, pursuant to Iowa Code §29C.9 the Polk County Emergency Management Commission ("Commission") does exist and operate, being composed of duly-appointed representatives of the following governmental entities: the Cities of Alleman, Altoona, Ankeny, Bondurant, Clive, Des Moines, Elkhart, Grimes, Johnston, Mitchellville, Pleasant Hill, Polk City, Runnells, Urbandale, West Des Moines, and Windsor Heights, and the County of Polk; and

WHEREAS, pursuant to Iowa Code §29C.17 the budget of the Commission may be funded all or in part by a per capita allocation funded from city and county general funds and it is the intent and desire of the Commission and its Members to fund administration of the Commission through an annual per capita allocation funded from city and county general funds; and

WHEREAS, on April 22, 2011, by Roll Call No. 11-0480, the City Council approved a 28E Agreement with the Commission for Funding of Emergency Management Administration for a three year term, which term has expired, and the City Council has determined that continuation of such 28E Agreement is in the best interests of the citizens of the City of Des Moines.

Now, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, approves the 28E Agreement between Members of the Polk County Emergency Management Commission For Funding of Emergency Management Administration, a copy of which is on file in the City Clerk's Office, and has caused this Agreement to be executed by the Mayor on behalf of the City on the day and year indicated below.
