PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON ELM GROVE CEMETERY ROADWAY IMPROVEMENTS; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS GRIMES ASPHALT & PAVING CORP., KURT RASMUSSEN, PRESIDENT, \$168,487.50

WHEREAS, on July 14, 2014, under Roll Call No. 14-1032, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Elm Grove Cemetery Roadway Improvements, 11-2014-009

This improvement includes reconstruction of roadways in Elm Grove Cemetery, 12' and 16' wide HMA that is 5" thick with 6" road base, together with pavement removal, excavation, storm drainage, surface restoration, and miscellaneous associated work including cleanup; in accordance with the contract documents, including Plan File Nos. 560-133/154, at Elm Grove Cemetery, 6501 Indianola Avenue, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.


