**RESOLUTION APPROVING CHAPTER 28E AGREEMENT BETWEEN CITY OF DES MOINES, CITY OF URBANDALE, AND UNIVERSITY OF NORTHERN IOWA FOR ADMINISTRATION OF THE UNIVERSITY’S CENTER FOR ENERGY & ENVIRONMENTAL EDUCATION’S GREEN IOWA AMERICORP PROGRAM WITHIN THE CITIES OF DES MOINES AND URBANDALE**

**WHEREAS**, the University of Northern Iowa’s (UNI) Center for Energy & Environmental Education administers a Green Iowa AmeriCorp Program, a part of which includes selecting AmeriCorps participants (hereafter “Participants”) to operate and provide services such as home energy audits and home improvements to residents within the cities of Des Moines and in Urbandale (hereafter “Program”); and

**WHEREAS**, UNI has requested and Des Moines has agreed that Des Moines will provide storage, office space, and other items to the Participants and will help administer the Program within Des Moines; and

**WHEREAS**, UNI and Des Moines have requested and Urbandale has agreed that Urbandale will provide a vehicle and equipment to the Participants and will help administer the Program within Urbandale as set forth herein; and

**WHEREAS**, staff for Des Moines, Urbandale and UNI have negotiated a 28E Agreement, substantially in the form as on file in the office of the City Clerk, setting forth the terms of local administration of the Program including but not limited to the requirements that the City of Des Moines fund up to \$6,400.00 toward Program costs, provide storage, office space and computer equipment for up to five Participants, provide gasoline for one vehicle used by the Participants solely for Program functions, identify designated Des Moines neighborhoods within which Participants are to undertake the Program, and provide staffing from the City Manager’s office to supervise the Participants during the one-year term of the Agreement.

**NOW THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, as follows:

1. The Chapter 28E Agreement by and between the City of Des Moines, Iowa, City of Urbandale, and University of Northern Iowa, for Administration of the University’s Center for Energy & Environmental Education’s Green Iowa AmeriCorp program within the Cities of Des Moines and Urbandale, is hereby approved, subject to approval as to form by the Legal Department and approval by UNI and the City of Urbandale of said Agreement, and the Mayor and City Clerk are hereby authorized and directed to execute and attest said Agreement, respectively.
2. The City Manager and his designee are hereby authorized and directed to administer the terms of said 28E Agreement.
