ACCEPTING PROPOSAL FOR A SCHOOL FLASHER SYSTEM AND RELATED IMPLEMENTATION SERVICES FROM TRAFFIC & PARKING CONTROL CO., INC. AND AUTHORIZING THE MAYOR TO EXECUTE AGREEMENTS FOR THE PROVISION OF SAME AND CITY MANAGER TO EXECUTE RENEWALS

WHEREAS, the Traffic and Transportation Division desires to procure a School Flasher System, including installation of equipment, software license, hosting and maintenance/technical support, and cellular modem service; and

WHEREAS, on February 20, 2014, the Procurement Administrator issued a Request for Proposal (RFP V14-056) for School Flasher System Upgrade ("City's RFP") to 7 proposers and 4 proposals were received; and

WHEREAS, an Evaluation and Selection Committee has reviewed and evaluated the proposals and has recommended that a contract for such services be awarded to Traffic & Parking Control Co., Inc., a Wisconsin Corporation located at 5100 West Brown Deer Road, Brown Deer, Wisconsin 53223 (TAPCO); and

WHEREAS, City staff have negotiated an agreement with TAPCO for initial term of 5 years, with up to three additional terms of 3 years each, with pricing to be mutually agreed upon, for installation of the system, and hosting, maintenance and technology support services, training, and software license, as described in the City's RFP, TAPCO's proposal and as described in the attached Council Communication, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the TAPCO proposal for the above described school flasher system is hereby accepted and approved and the Mayor is hereby authorized and directed to execute the above described agreement, including all licenses, a copy of which is on file in the City Clerk's Office.

BE IT FURTHER RESOLVED that the City Manager is authorized to negotiate and execute on behalf of the City up to three 3 year renewals limited to no more than a 5% increase for each 3 year renewal term, subject to approval as to form by the Legal Department.
