## SET HEARING FOR APPROVAL OF A PROPOSED LEASE AGREEMENT WITH THE DES MOINES BICYCLE COLLECTIVE FOR PLACEMENT OF B-CYCLE PROGRAM KIOSKS ON CITY RIGHT-OF-WAY

WHEREAS, CITY is the titleholder of certain street right-of-way located at the intersection of 12th Street and Grand Avenue and the intersection of 10th Street and Walnut Street, Des Moines, Iowa (Leased Premises); and

WHEREAS, the Des Moines Bicycle Collective wishes to lease the Leased Premises for the placement of and operation of the B-Cycle Program bicycle kiosks; and

WHEREAS, the City's Real Estate Division has negotiated a Lease Agreement with the Des Moines Bicycle Collective as Lessee, which Agreement will include, among other terms, a license term commencing upon execution by City of the Lease Agreement and terminating on November 30, 2019, and subject to termination by either party, with or without cause, upon thirty (30) calendar days written notice; and

WHEREAS, pursuant to the negotiated Lease Agreement, Des Moines Bicycle Collective shall use the Leased premises for the placement of and operation of the B-Cycle Program bicycle kiosks, in accordance with all applicable local, state and federal laws and requirements, including but not limited to site plan requirements, and in accordance with the agreement between the City of Des Moines and the Des Moines Bicycle Collective for development and completion of bicycle sharing stations approved by the Des Moines City Council on 2/25/13 by Roll Call Not 3-0293 ("ICAAP Agreement) and further agrees to provide the following throughout the entire term of the Lease Agreement: (a) mowing of all grassed areas and trimming and maintenance of all landscaping within the Leased Premises; (b) cut and remove any weeds growing on the Leased Premises; (c) keep the premises free from nuisances and debris; (d) maintain the premises in a clean, safe and attractive condition (e) clearing of snow, ice and other debris from and adjacent to the Leased Premises, including the adjacent sidewalks; and

WHEREAS, the lease of the Leased Premises for the purposes described herein will not adversely affect the use of adjoining real estate by CITY for municipal purposes and the City will not be inconvenienced by approval of the proposed Lease Agreement with Des Moines Bicycle Collective.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa proposes to enter into a Lease Agreement with Des Moines Bicycle Collective for the use of City right-of-way located at the intersection of 12th Street and Grand Avenue and the intersection of 10th Street and Walnut Street, Des Moines, Iowa, as shown in the attached Exhibit A, for the placement of and operation of the B-Cycle Program bicycle kiosks.
