APPROVING COMMUNITY SERVICES BLOCK GRANT (CSBG) CONTRACT FOR THE 2015 CSBG PROGRAM YEAR WITH THE IOWA DEPARTMENT OF HUMAN RIGHTS, DIVISION OF COMMUNITY ACTION AGENCIES

WHEREAS, the Des Moines Community Action Agency's mission is to provide services to low-income families and work to address and eliminate the causes of poverty; and

WHEREAS, the Iowa Department of Human Rights, Division of Community Action Agencies has now forwarded Contract No. CSBG-15-07, on file with the City Clerk as Exhibit "A" and by this reference made a part hereof; and

WHEREAS, Contract No. CSBG-15-07, by and between the Iowa Department of Human Rights, Division of Community Action Agencies and the City of Des Moines, allocates \$622,680 to the City of Des Moines for the provision of community services to low-income persons during the period from October 1, 2014 through December 31, 2015; and

WHEREAS, approval of Contract No. CSBG-15-07 is in the best interest of the City as it will provide for a variety of programs and services for low-income residents of Des Moines.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines that Contract No. CSBG-15-07, with a total contract budget of \$622,680, be and is hereby approved, and that the Mayor is hereby authorized and directed to execute the above-referenced contract and the City Clerk to attest to his signature.

NOW THEREFORE, BE IT FURTHER RESOLVED, that the City Manager is authorized and directed to execute any unsubstantial changes in the administrative terms, conditions, or amounts specified in this Contract, and the Housing Services Director or his designee is authorized and designated to sign all fiscal and program forms required by this Contract, including but not limited to funding requests, expenditure reports and budget amendment requests.
