ACCEPTING PROPOSAL OF RCC CONSULTANTS INC. TO PROVIDE CONSULTING SERVICES FOR A NEEDS ASSESSMENT STUDY FOR CONSOLIDATION OF COMMUNICATION CENTERS AND FUTURE RADIO NEEDS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE THE CONTRACT FOR THE PROVISION OF SAME

WHEREAS, The Des Moines Police Department desires to procure consultant services to conduct a feasibility study of co-location of City and Polk County dispatch centers, consolidation of the two dispatch services, and future radio needs assessment, and;

WHEREAS, the Procurement Division issued Request for Proposals V15-010 on August 28, 2014 for Consolidation of Services and Future Radio Needs to radio consulting firms, four proposals were received, and;

WHEREAS, an evaluation and selection committee reviewed the proposals and recommends the selection of RCC Consultants Inc. 2425 Millcreek Court, Tallahassee, FL 32308 based on their receipt of the highest score based on criteria described in the Request for Proposal.




