RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSITION TO AUTHORIZE A LEASE AGREEMENT BETWEEN THE CITY OF DES MOINES AND SCRANTON MANUFACTURING CO., INC. FOR THE RENTAL OF ONE REFUSE TRUCK FOR AN EIGHT-MONTH PERIOD AND FOR PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, it is deemed necessary and advisable that the City of Des Moines, Iowa, should enter into a Lease Agreement for the rental of a refuse truck to be used at the Solid Waste Division of the Department of Public Works, said lease to be for an approximately eight month period and said lease calls for eight monthly payments of \$7,800 plus fees and other charges as authorized by Sections 364.4 and 384.83 of the Code of Iowa; and

WHEREAS, the Lease Agreement shall be payable solely and only out of the Solid Waste Operation Fund; and

WHEREAS, before the Lease Agreement may be authorized, it is necessary to comply with the provisions of the Code of Iowa, as amended, and to publish a notice of the proposal and of the time and place of the meeting at which the City Council proposes to take action for the authorization of the Lease Agreement and to receive oral and written objections from any resident or property owner of the City to such action.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City Of Des Moines, Iowa:

Section 1. That the City Council meet in the Council Chambers, City Hall, Des Moines, Iowa, at 5:00 o'clock P.M., on the 8th day of December, 2014, for the purpose of taking action on the matter of the authorization of a Lease Agreement between the City of Des Moines and Scranton Manufacturing Co., Inc., for the rental of one refuse truck for the removal of solid waste, said lease to be for an approximately eight month period and said lease calls for eight monthly lease payments of \$7,800.00 each (with a total rental amount of \$62,400 plus fees and other charges) to be used by the Solid Waste Division of the Department of Public Works.

Section 2. That the City Clerk is hereby directed to cause a publication to be made of a notice of said meeting in a legal newspaper, printed wholly in the English language, not less than four clear days nor more than twenty days before the date of said public meeting on the authorization of said Lease Agreement.

Section 3. The notice of the proposed action to authorize said Lease Agreement shall be in substantially the following form:

PLUS FEES AND OTHER CHARGES) FOR THE PURPOSE OF LEASING A REFUSE TRUCK AND THE PUBLIC HEARING ON THE AUTHORIZATION THEREOF.

PUBLIC NOTICE is hereby given that the City Council of the City of Des Moines, Iowa, will hold a public hearing on the 8th day of December, 2014 at 5:00 o'clock P.M., in the Council Chambers, City Hall, Des Moines, Iowa to take additional action for the authorization of a Lease Agreement between the City of Des Moines and Scranton Manufacturing Co., Inc. in the principal amount of eight monthly lease payments of \$7,800 each (resulting in total rental payments of \$62,400 plus fees and other charges) to pay costs of renting of one refuse truck to be used for removal of solid waste by the Solid Waste Division of the Department of Public Works. The Lease Agreement will be payable from the Solid Waste Operations Enterprise Fund.

At the above meeting the City Council shall receive oral or written objections from any resident or property owner of the City to the above action. After all objections have been received and considered, the City Council will at this meeting or at any adjournment thereof, take additional action for the authorization of said Lease Agreement or will abandon the proposal.

This notice is given by order of the Council of Des Moines, Iowa, as provided in Sections 364.4 and 384.83 of the Code of Iowa, as amended.
