**RESOLUTION APPROVING AGREEMENT BETWEEN CITY OF DES MOINES AND
UNIVERSITY OF NORTHERN IOWA FOR ADMINISTRATION OF THE
UNIVERSITY'S CENTER FOR ENERGY & ENVIRONMENTAL EDUCATION'S
GREEN IOWA AMERICORP PROGRAM**

WHEREAS, the University of Northern Iowa's (UNI) Center for Energy & Environmental Education administers a Green Iowa AmeriCorp Program, a part of which includes selecting AmeriCorps participants (hereafter "Participants") to operate and provide services such as home energy audits and home improvements to certain residents within the city of Des Moines (hereafter "Program"); and

WHEREAS, UNI has requested and Des Moines has agreed that Des Moines will provide storage, office space, and other items to the Participants and will help administer the Program within Des Moines; and

WHEREAS, on September 8, 2014, by Roll Call No. 14-1378, the City Council approved a Chapter 28E Agreement by and between the City, the City of Urbandale, and UNI for administration of the Program; and

WHEREAS, following said approval, the City of Urbandale has elected not to participate in the Program or Agreement; and

WHEREAS, staff for Des Moines and UNI have negotiated a revised Agreement, substantially in the form as on file in the office of the City Clerk, setting forth the terms of local administration of the Program including but not limited to the requirements that the City of Des Moines fund up to \$8,000.00 toward Program costs, provide storage, office space and computer equipment for up to five Participants, provide gasoline for one vehicle and a vehicle if required to be used by the Participants solely for Program functions, identify designated Des Moines neighborhoods within which Participants are to undertake the Program, and provide staffing from the City Manager's office to supervise the Participants during the one-year term of the Agreement; and

WHEREAS, approval of the revised Agreement is intended to supersede the approval granted by Roll Call No. 14-1378.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The Agreement by and between the City of Des Moines and University of Northern Iowa for Administration of the University's Center for Energy & Environmental Education's Green Iowa AmeriCorp program within the city of Des Moines is hereby approved, subject to approval as to form by the Legal Department, and the Mayor and City Clerk are hereby authorized and directed to execute and attest said Agreement, respectively.
