APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION
CONTRACT FOR ZOO IMPROVEMENTS, AUSTRALIAN TRAIL ADVENTURE AT BLANK PARK ZOO,
BETWEEN NEUMANN BROTHERS, INC. AND BLANK PARK ZOO FOUNDATION, INC.

WHEREAS, on October 25, 2010 under Roll Call No. 10-1791, the City Council approved a private construction contract in the amount of \$525,000.00, between Neumann Brothers, Inc., Marshall G. Linn III, President/CEO, 1435 Ohio Street, Des Moines, IA, 50314 - as Contractor, and Blank Park Zoo Foundation, Inc., Mark R. Vukovich, CEO, 7401 SW 9th Street, Des Moines, IA, 50315 - as Owner, for construction of Zoo Improvements described as rough grading, demolition and building foundations for the Australian Trail Adventure in accordance with the contract documents including Plan File Numbers 449-019/076 at Blank Park Zoo, 7401 SW 9th Street, Des Moines, Iowa, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines Interim City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines Interim City Engineer acknowledging the completion and recommending the acceptance of the construction of said Zoo Improvements in the amount of \$525,000.00, which have been constructed in substantial compliance with the contract documents between Neumann Brothers, Inc. and Blank Park Zoo Foundation, Inc., which were approved under Roll Call No. 10-1791, dated October 25, 2010, be received and filed; and that completion of said Zoo Improvements described as rough grading, demolition and building foundations for the Australian Trail Adventure in accordance with the contract documents including Plan File Numbers 449-019/076 at Blank Park Zoo, 7401 SW 9th Street, Des Moines, Iowa, is hereby acknowledged and that said Zoo Improvements are hereby accepted.
