APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION  
CONTRACT FOR PRINCIPAL RIVERWALK SIGNAGE AND SKATING CANOPY IMPROVEMENTS,  
PRINCIPAL RIVERWALK,  
BETWEEN JENSEN CONSTRUCTION COMPANY AND PRINCIPAL LIFE INSURANCE COMPANY

WHEREAS, on April 22, 2013 under Roll Call No. 13-0630, the City Council approved a private construction contract in the amount of \$253,000.00, between Jensen Construction Company, Kurt E. Rasmussen, Owner, 5550 NE 22nd Street, Des Moines, IA, 50313 - as Contractor, and Principal Life Insurance Company, Larry Zimpleman, Chairman, President, 711 High Street, Des Moines, IA, 50392 - as Owner, for construction of Principal Riverwalk Signage and Skating Canopy Improvements described as construction of Principal Riverwalk Improvements which include foundations for the future Brenton Skating Plaza Canopy, signage noting the Hub Spot Plaza and also Donor Recognition signage, signage renaming the Center Street Bridge as the Iowa Women of Achievement Bridge, and signage at the Brenton Skating Plaza, as per Plan File Nos. 552-01/22, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines Interim City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines Interim City Engineer acknowledging the completion and recommending the acceptance of the construction of said Principal Riverwalk Signage and Skating Canopy Improvements in the amount of \$253,000.00, which have been constructed in substantial compliance with the contract documents between Jensen Construction Company and Principal Life Insurance Company, which were approved under Roll Call No. 13-0630, dated April 22, 2013, be received and filed; and that completion of said Principal Riverwalk Signage and Skating Canopy Improvements described as construction of Principal Riverwalk Improvements which include foundations for the future Brenton Skating Plaza Canopy, signage noting the Hub Spot Plaza and also Donor Recognition signage, signage renaming the Center Street Bridge as the Iowa Women of Achievement Bridge, and signage at the Brenton Skating Plaza, as per Plan File Nos. 552-01/22, is hereby acknowledged and that said Principal Riverwalk Signage and Skating Canopy Improvements are hereby accepted.
