**APPROVAL OF A CDBG PROJECT AGREEMENT WITH
NEIGHBORHOOD DEVELOPMENT CORPORATION (NDC) FOR
REDEVELOPMENT PROJECT AT 2440 SW 9TH STREET**

WHEREAS, the commercial structure located at 2440 SW 9th Street is vacant, has been determined to be in below normal condition by the Polk County Assessor, has been determined by City officials to be a blighted structure, and poses an impediment to the redevelopment of the SW 9th Street corridor; and

WHEREAS, the redevelopment of 2440 SW 9th Street was identified as a high priority by the Friends of SW 9th Street and by the Neighborhood Development Division of the City's Community Development Department; and

WHEREAS, Neighborhood Development Corporation (NDC) proposes to redevelop 2440 SW 9th Street, following acquisition and demolition of the existing structure and, with City staff, selection of a suitable for-profit or non-profit developer to purchase the property from NDC, subject to affordability covenants and with purchase proceeds returned to the City as project income, for development of a new low-rent multi-family housing or mixed use project on the property; and

WHEREAS, the City of Des Moines has allocated \$318,000 of Community Development Block Grant (CDBG) funding for fiscal year 2014 for Neighborhood Revitalization Plan Implementation; and

WHEREAS, the City proposes to utilize \$100,000 of such CDBG funding to assist NDC in the 2440 SW 9th Street project for redevelopment of the blighted property and for low-rent housing purposes, pursuant to the Neighborhood Revitalization Plan; and

WHEREAS, NDC's proposed project for redevelopment of 2440 SW 9th Street is set forth in a CDBG Project Agreement between the City and NDC, substantially in the form on file in the office of the City Clerk, and, due to the nature and amount of such Agreement, the Agreement is being presented to City Council for consideration and approval.
