The City Clerk is hereby directed to continue to make available a sufficient number of copies of the proposed annual budget for the fiscal year ending June 30, 2016, to meet the requests of taxpayers and organizations and to have copies of the proposed budget available for distribution at the offices of the Mayor and City Clerk and at the City libraries.
- 2. The public hearing on the City's proposed annual budget for the fiscal year ending June 30, 2016 is hereby fixed and set for the 9th day of March, 2015 at 5:00 o'clock P.M. in the Council Chambers in City Hall, Des Moines, Iowa, at which time any resident or taxpayer of the City may be heard for or against the proposed budget.
- 3. The City Clerk be and is hereby authorized and directed to execute and publish notice of said hearing in the attached form in the Des Moines Register, a newspaper of general circulation in the City of Des Moines, Polk County, Iowa, in accordance with Iowa Code Section 384.16(3), not less than ten (10) nor more than twenty (20) days prior to the date set for said hearing.
