WHEREAS, the Permit and Development Center recommends the City Council conditionally approve the final subdivision plat subject to the conditions identified below.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. It is hereby determined that the subdivision plat identified above conforms to the Des Moines 2020 Community Character Land Use Plan and the subdivision will not unduly burden public improvements in the area and will provide an appropriate balance of interest between current proprietors, future purchasers and the public interest.
- 2. The subdivision is hereby approved, subject to receipt of an updated title opinion and attachments to the plat, and approval of the same by the City's Legal Department.
- 3. Upon satisfaction of the conditions set forth above, the Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat as appropriate.
- 4. The City Clerk is hereby directed to provide the approved subdivision plat, a certified copy of this resolution, the attorney's title opinion and the attachments to the plat to the Community Development Department for delivery to the County Auditor for recording by the plat proprietors. The City Clerk is hereby further directed to send a copy of the subdivision plat to the Board of Education, Centurylink Communications, Mid-American Energy, Mediacom, Des Moines Water Works, U.S. Post Office—Post Master, U.S. Post Office—Technical Sales and Services, City Engineering, City Land Records, Public


