SET HEARING FOR VACATION OF PARKLAND IN PIONEER PARK AND DEDICATING IT AS PIONEER ROAD RIGHT-OF-WAY AND VACATION OF PIONEER ROAD RIGHT-OF-WAY WITHIN PIONEER PARK AND DEDICATING IT AS PARKLAND

WHEREAS, the City of Des Moines Parks and Recreation Department initiated a request for the vacation of parkland in Pioneer Park and its dedication as Pioneer Road right-of-way, and for the vacation of a portion of Pioneer Road right-of-way within Pioneer Park and its dedication as parkland; and

WHEREAS, there is no known current or future public need or benefit for the parkland or right-of-way proposed to be vacated and the City will not be inconvenienced by the vacation of said right-of-way, subject to reservation of easements for any existing utilities currently located within the right-of-way.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a portion of parkland in Pioneer Park for the purpose of dedicating such parkland as Pioneer Road right-of-way, and adoption of an ordinance permanently vacating a portion of Pioneer Road right-of-way adjoining Pioneer Park for the purpose of dedicating said portion of right-of-way as parkland, all legally described as follows:

Legal Description of Parkland to be Vacated:

ALL OF THE SOUTH 20 FEET OF THE NORTH 94.45 FEET OF THE SOUTHEAST 1/4 OF THE NORTHWEST 1/4 OF SECTION 14, TOWNSHIP 78 NORTH, RANGE 24 WEST OF THE 5TH P.M. LYING BETWEEN THE NORTHERLY EXTENSION OF THE WEST LINE OF LOT 5, PIONEER PLACE, AN OFFICIAL PLAT, AND THE WEST LINE OF SAID SOUTHEAST 1/4 OF THE NORTHWEST 1/4 OF SECTION 14, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA

Legal Description of Pioneer Road to be Vacated:

ALL OF THE SOUTH 20 FEET OF THE NORTH 114.45 FEET OF THE SOUTHEAST 1/4 OF THE NORTHWEST 1/4 OF SECTION 14, TOWNSHIP 78 NORTH, RANGE 24 WEST OF THE 5TH P.M. LYING BETWEEN THE NORTHERLY EXTENSION OF THE WEST LINE OF LOT 5, PIONEER PLACE, AN OFFICIAL PLAT, AND THE EAST LINE OF SAID SOUTHEAST 1/4 OF THE NORTHWEST 1/4 OF SECTION 14;

AND, ALL OF LOT "D" IN SAID PIONEER PLACE,

ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.
