WHEREAS, on March 9, 2015, by Roll Call No. 15-0407, the City Council approved awards to ABM Onsite Services and Reliable Maintenance; and

WHEREAS, ABM Onsite Services has since been found to be non-compliant regarding insurance and indemnification terms and conditions and therefore has withdrawn their proposal; and

WHEREAS, Reliable Maintenance, the second low dollar compliant bidder is unable to accept Bid Package 3 due to manpower restrictions and has withdrawn their proposal for Package 3; and

WHEREAS, the low dollar compliant bid for Bid Package 3 was received from Marsden Building Maintenance, LLC, 2801 Bell Ave., Des Moines, IA 50321, Chad Cordaro, Vice President/General Manager in the annual amount of \$95,196.00; and

WHEREAS, funding is available from various departmental operating budgets at an annual estimated amount of \$318,000.00 for Bid Packages 1-4; and

WHEREAS, the Procurement Administrator and the Park and Recreation Department recommend approval of the low dollar compliant bid for custodial services from Marsden Building Maintenance, LLC.


