PUBLIC HEARING FOR APPROVAL OF THE 2014 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)

WHEREAS, provisions under 24 CFR 91.520 regarding reporting on the implementation and management of the Consolidated Plan for HUD grant programs require the City to submit a Consolidated Annual Performance and Evaluation Report (CAPER) for the 2014 Program Year to the United States Department of Housing and Urban Development (HUD) no later than 90 days after completion of the 2014 Consolidated Plan Program Year; and

WHEREAS, the City Council must conduct a public hearing to review the 2014 HUD Consolidated Plan Program Year performance and receive citizen comments regarding the CAPER for the 2014 Consolidated Plan Program Year, and provide notice of the hearing to be published at least fifteen and no more than twenty days before it is held; and

WHEREAS, on February 23, 2015 by Roll Call No. 15-0288, in compliance with the HUD regulations, the City Council set a public hearing for March 23, 2015 at 5:00 p.m. to obtain citizen comments regarding the Consolidated Annual Performance and Evaluation Report (CAPER) to the 2014 Program Year; and

WHEREAS, due notice of the public hearing was published in the Des Moines Register on March 5, 2015, and copies of the proposed CAPER for the 2014 Program Year were made available for public review at the City Clerk's Office and at all library branches in order to provide citizens with the opportunity to participate in the hearing; and

WHEREAS, the public hearing on this date has been opened and those seeking to comment on the CAPER for the 2014 HUD Consolidated Plan Program Year have been afforded the opportunity to do so.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. All public comments regarding the 2014 HUD Consolidated Plan Program Year have been received and the hearing is hereby closed.
- 2. The Consolidated Annual Performance and Evaluation Report (CAPER) for the 2014 HUD Consolidated Plan Program Year, on file with the City Clerk and by this reference made a part hereof, is hereby approved.
- 3. The City Manager or his designee is hereby authorized and directed to submit the CAPER for the 2014 HUD Consolidated Plan Program Year to the U.S. Department of Housing and Urban Development.
