AUTHORIZING SUBMITTAL OF A FY2016 HISTORICAL RESOURCE DEVELOPMENT PROGRAM (HRDP) GRANT APPLICATION TO THE STATE HISTORICAL SOCIETY OF IOWA FOR A NATIONAL REGISTER OF HISTORIC PLACES DISTRICT NOMINATION IN THE NORTH OF GRAND NEIGHBORHOOD

WHEREAS, the State of Iowa provides funding annually for grant usage to the Resource Enhancement and Protection (REAP) and Historical Resource Development Program (HRDP); and,

WHEREAS, the purpose of the REAP/HRDP Grants Program is to provide funds to preserve, conserve, interpret, enhance, and educate the public about the historical resources of Iowa; and,

WHEREAS, the State Historical Society of Iowa (SHSI) is accepting applications until April 30, 2015 for the Fiscal Year (FY) 2016 REAP/HRDP Grants Program; and,

WHEREAS, the North of Grand Neighborhood Association (NOG) has requested that the City of Des Moines, through the Community Development Department, submit an application for a FY2016 HRDP grant for funding in the amount of \$13,000, with additional requirements of a \$5,200 cash match and a \$1,565 in-kind match to be paid by the NOG Neighborhood Association, for a total estimated project cost of \$19,765; and,

WHEREAS, if awarded, the HRDP grant funds would be used to hire a qualified consultant to complete the National Register of Historic Places nomination process for one or more potentially eligible historic districts within the NOG neighborhood.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the City Manager is hereby authorized to submit a FY2016 HRDP grant application to the State Historical Society of Iowa for use in the North of Grand Neighborhood as described above.
