APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE RFP PROCESS FOR GOOD CAUSE AND ACCEPTING PROPOSAL OF LYLE SUMEK ASSOCIATES, INC. TO PROVIDE STRATEGIC PLANNING CONSULTING SERVICES AND AUTHORIZING CITY MANAGER TO NEGOTIATE AND EXECUTE CONTRACT FOR THE PROVISION OF SAME

BE IT FURTHER RESOLVED that the proposal submitted by Lyle Sumek Associates, Inc. is hereby accepted and the City Manager is authorized and directed to negotiate and execute an agreement with Lyle Sumek Associates, Inc. to provide strategic planning consulting services as described above for and on behalf of the City of Des Moines, subject to approval as to form by the Legal Department, and the City Clerk is authorized to attest to his signature.
