APPROVAL OF DONATION AND INSTALLATION AGREEMENT WITH JONATHAN LATCH FOR FUNDING AND INSTALLATION OF DISC GOLF COURSE AT PROSPECT PARK AND NAMING OF DISC GOLF COURSE THE BECKY ZALLEK DISC GOLF COURSE

WHEREAS, the City Park and Recreation Department is charged with the responsibility of providing safe Disc Golf Courses within the City of Des Moines; and

WHEREAS, Jonathan Latch desires to raise funds for the charitable fund operated by the Community Foundation of Greater Des Moines designated as the "Becky Zallek Disc Golf Course Fund" dedicated to the funding and procurement of equipment and the installation of an eighteen (18) station disc golf course at a site at Prospect Park at 1225 Prospect Drive (the "Disc Golf Improvements"); and

WHEREAS, the project will not be started until sufficient funds have been raised for construction of the Disc Golf Improvements; and

WHEREAS, Park and Recreation Department staff and Jonathan Latch have negotiated a Donation Agreement for Funding and Installation of the Becky Zallek Disc Golf Course, a copy of which is on file in the City Clerk's Office; and

WHEREAS, the City Council finds that it is in the best interests of the City to approve this Donation Agreement; and

WHEREAS, on December 8, 2014, by Roll Call No. 14-1888, the City Council referred to the City Manager and Park and Recreation Board for review and recommendation under the City's Policy for Naming of Streets, Facilities and Park Land a request by Council Member Gray to name a proposed new disc golf course to be constructed at Prospect Park in honor of Des Moines resident Becky Zallek; and

WHEREAS, in accordance with such Policy, the Park and Recreation Board held a public hearing at its meeting on March 24, 2015, and unanimously voted to approve the recommendation of naming the proposed disc golf course at Prospect Park as the "Becky Zallek Disc Golf Course"

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the Donation Agreement for Funding and Installation of the Becky Zallek Disc Golf Course, a copy of which is on file in the City Clerk's Office, is hereby approved and the Mayor is authorized and directed to sign the Agreement on behalf of the City and the City Clerk is authorized and directed to attest to his signature.
