WHEREAS, the City's Housing Services Department includes the Des Moines Municipal Housing Agency ("DMMHA") and the Des Moines Community Action Agency ("DMCAA"); and

WHEREAS, the DMCAA is federally funded; and

WHEREAS, federal funding reductions have resulted in budget losses with a negative impact on DMCAA programs and services; and

WHEREAS, in order to maximize program and service opportunities, the City of Des Moines has agreed to transfer such programs and services to the Red Rock Area Community Action Program, Inc. ("Red Rock"); and

WHEREAS, the employees assigned to DMCAA are City of Des Moines employees; and

WHEREAS, in order to accomplish the transfer of DMCAA to Red Rock, six employees in several job classifications, some of which are covered by civil service, must be reduced as more specifically outlined in the accompanying Council Communication; and

WHEREAS, Section 400. 28 of the Iowa Code states that "...when the public interest requires a diminution of employees..." the city council is authorized to reduce the number of employees in a classification and that action will not give rise to an appeal challenging that action before the civil service commission; and

WHEREAS, it is anticipated that the lay-off date for these six employees will be September 30, 2015; and

WHEREAS, such a reduction of employees is necessary to effect the City's agreement with Red Rock.
