WHEREAS, Hall & Associates was retained by the Des Moines Metropolitan Wastewater Reclamation Authority (WRA) on April 18, 2006, by Resolution No. 06-39 and by the City of Des Moines on April 10, 2006 by Resolution No. 06-651 to provide professional consultation and representation services to the WRA regarding an alleged IDNR violation, the negotiation of the a consent decree for implementation of a Long-Term Control Plan for the combined sewer system and combined sewer overflows required by the WRF National Pollution Discharge Elimination System (NPDES) Permit; and

WHEREAS, the WRA's current NPDES Permit was negotiated and included as part of the Consent Decree which was approved by the WRA on March 16, 2010 by Resolution No. 10-48; and

WHEREAS, the WRA's NPDES Permit includes "Special Conditions – Combined Sewer Overflows" that apply to the City of Des Moines as the sole entity that is responsible and liable for the operations and control of the overflows identified in the special conditions as City owned outfalls; and

WHEREAS, the WRA retained Hall & Associates on February 17, 2015 to provide consultation and representation services to the WRA regarding negotiation of its NPDES Permit and the City Council approved retaining Hall & Associates on February 23, 2015 for the "Special Conditions – Combined Sewer Overflow" included as a part of the WRA's NPDES Permit; and

WHEREAS, there are regulatory proposals by the Iowa Department of Natural Resources (IDNR) that require evaluation as to how they may impact the WRF and the City of Des Moines' MS4 Permit; and

WHEREAS, the WRA has also determined it advisable to retain Hall & Associates for the evaluation and comment on the proposed IDNR regulations as a joint submission with the City's comments and authorized the fees be allocated between the WRA and City as determined appropriate by the WRA Director and City of Des Moines Public Works Director; and

WHEREAS, it is the recommendation of staff that Hall & Associates be retained by the City to provide evaluation and comment on the proposed IDNR regulations jointly with the WRA; and
