RESOLUTION IN SUPPORT OF A WORKFORCE HOUSING TAX CREDIT (WHTC)
BENEFIT APPLICATION TO BE SUBMITTED TO THE IOWA ECONOMIC
DEVELOPMENT AUTHORITY (IEDA) BY ROERS INVESTMENTS, INC. FOR A
HOUSING PROJECT AT 103 AND 123 SW 3RD STREET AND 106 AND 112 SW 2ND STREET

WHEREAS, Roers Investments, Inc., represented by Jeff Koch, Partner, has requested City support for its application to the Iowa Economic Development Authority ("IEDA") for state tax incentives under the Workforce Housing Tax Credit Program for a \$40,000000, 211-unit housing project at 103 and 123 SW 3rd Street and 106 and 112 SW 2nd Street; and

WHEREAS, successful completion of the Roers Investments, Inc. project requires funding from a number of sources, including an award of Iowa Workforce Housing Tax Credit benefits in the estimated amount of \$1,000,000; and

WHEREAS, the application requirements for the Workforce Housing Tax Credit Program include a requirement for the submission of a resolution in support of the housing project by the community where the housing project will be located, which requirement is intended to be satisfied by this roll call and resolution; and

WHEREAS, a further application requirement for the Workforce Housing Tax Credit Program is documentation of local matching funds pledged for the project in an amount not less than \$1,000 per dwelling unit; and

WHEREAS, the Roers Investments, Inc. project is located within the City-wide Urban Revitalization Area and provided that the project is completed as planned, the taxable value added to the property by completion of the project will qualify for a temporary exemption from property taxes (a/k/a tax abatement) under the 10-year 100% tax abatement schedule, providing financial assistance of approximately \$3,177,800 based on the estimated annual property taxes.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council of the City of Des Moines does hereby express its support for the Roers Investments, Inc. application to the IEDA, seeking an award of Workforce Housing Tax Credit benefits in the amount of \$1,000,000 for the above-described project.
- 2. The Mayor and the City Manager are hereby authorized and directed to sign any forms required by the Administrative Rules of the IEDA to evidence the City's support for the application by Roers Investments, Inc. as described above, upon approval of the same by the City Legal Department.
- 3. The Office of Economic Development is directed to transmit a copy of this resolution and roll call to Roers Investments, Inc. for submittal to the IEDA, and to conduct project compliance monitoring.
- 4. In the event that any of the project characteristics mentioned above should change prior to the final award of tax credit benefits to Roers Investments, Inc., then:
