APPROVING AGREEMENT WITH DES MOINES WATER WORKS, METRO WASTE AUTHORITY, AND DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY TO TERMINATE URBAN ENVIRONMENTAL PARTNERSHIP 28E AGREEMENT.

WHEREAS, on November 20, 2000, by Roll Call No. 00-4370, the City Council approved an Intergovernmental 28E Cooperative Agreement with Des Moines Regional Wastewater Reclamation Authority (WRA), the Board of Water Works Trustees of City of Des Moines (DMWW) and the Metro Waste Authority (MWA) for the Urban Environmental Partnership to provide an integrated community education program designed to protect water quality in the urban watershed.; and

WHEREAS, the initial term of the 28E Agreement ended in December, 2001, with automatic one year renewals unless terminated by mutual agreement of the parties; and

WHEREAS, the parties desire to terminate the 28E Agreement effective on July 1, 2015.

WHEREAS, the City has prepared an Agreement to terminate the 28E Agreement, a copy of which is on file in the City Clerk's Office; and

WHEREAS, the Public Works Department recommends approval of this Agreement as Iowa Department of Natural Resources permit storm water educational requirements will be accomplished through other available programs.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Termination of Chapter 28E Agreement for Urban Environmental Partnership between the City of Des Moines, Des Moines Metropolitan Wastewater Reclamation Authority, Board of Water Works Trustees of City of Des Moines, and Metro Waste Authority, a copy of which is on file with the City Clerk, is hereby approved and the Mayor and City Clerk are hereby authorized and directed to execute and attest respectively said agreement for and on behalf of the City of Des Moines, Iowa.
